- 8- Party A shall be providing complete sales details on monthly basis to do the needful if it's in terms of compensation to Party B.

RESPONSIBILITIES OF PARTY B:

- 1- Part B shall never allow any vendor to provide uniforms to their students.
- 2- Party B shall provide Students' information to Party A.
- 3- Party B shall allow Party A for desired Branding.
- 4- Party B shall bound to recommend Party A to their consumers as their uniform / services provider.
